

The strength, courage, and shared confidence that we will get through this together. Our organisation has continued to make positive impact to the community and the interpreters.

In July 2021, we hosted our first Christmas in July event with delicious food, the event turns out to be a success with a huge number of attendees.

Unfortunately, the covid lockdown has returned, in August for 6 weeks which has left us no choice to put everything on hold until it was all safe to come out.

I just want to thank to Michael Hall, the CEO of Sprint Agency in Brisbane for setting up a team to work with us on building DeafACT a brand-new website, which is now live, where all the events and news are published. Events such as BBQ, AGM and movie events will be shown. If you are not a member of DeafACT, you can sign up online. The website is continuing to improve overtime so please be patient with us.

We also, were sad to see Brad Jones go, he has left the organisation and I thank him for his time and his hard-working effort with the deaf community and I wish him the best with his new job.

The following months, with Auslan Rights team, after so many meetings we submitted a petition to the ACT Legislative Assembly which got approved for Auslan Rights Petition. The petition has been spreading across the Deaf community and the public who supported Auslan. By 30 November, we achieved our minimum goal of 500, we got 536 signatures. I thank to everyone who signed the petition.

The petition is the reason we are working on today to have our rights to access Auslan across main pressure points for the community such as mental health, education, emergency services and hospital etc. This is important to advocate for all of us. This is ongoing project that I have been leading on for DeafACT and the ACT Government.

The petition was tabled to the ACT Legislative Assembly on February 8 and was referred to Education and inclusion team and was eventually approved for public inquiry, I thank all these people who provided their submission to them to assist with their inquiry. We will expect a report from them hopefully by the end of the year.

We also have formed a senior's group, under DeafACT with the leaders of Vera Hall and Mandy Dolejsi, the seniors meet up to discuss what they would love to do and propose to DeafACT, where we fund for their social events. The seniors have been enjoying it so far.

DeafACT has also done first aid course with St Johns Ambulance, so we are all certified, so you're all in safe hands!

In the past year, DeafACT has welcomed few members Kathe O'Brien who is the vice president for DeafACT and Kellyanne who joined us, where she represents for PODC (Parents of deaf children).

We also have been exposed in the media couple of times in regards of the petition which is brilliant.

As we wrap up for 2021/2022 financial year, we continued with more family BBQs which is a family favourite, please enjoy the food, and we have some exciting news – for these coffee lovers, we have coffee van coming at 11am, all kinds of coffee and tea, all free!
