With the easing of COVID restrictions, we've been actively working to bring you a diverse range of events. Reflecting on the past year – it's been a special time! In November, we organised a bus for the community to attend the Deaf Festival in Sydney, creating wonderful memorable experiences for all who joined.

December was a big month. The AGM and BBQ 2022 was a significant gathering where we announced the new President and Vice President. Jacob, our previous President, passed the baton, and I happily stepped into the role of President-elect. The performance of the Deaf Butterflies by the Deaf Seniors group at the Belconnen Art Centre was a beautiful highlight, and we eagerly anticipate their next performance next week! Additionally, two of our esteemed board members received special recognition - Lauren received the Sue Salthouse Leadership Fund, and Laisarn received the "Achievement in Inclusion" award from the ACT Government.

In February 2023, DeafACT teamed up with Dragonboat ACT for some training and thrilling races with other teams. I'm delighted to share that we are finalists at the ACT Sport Awards in the inclusion category for the "Minister for Sport and Recreations Award for Inclusion". A heartfelt congratulations to everyone who participated and the community that showed their massive support! A special acknowledgement to Kathe O'Brien for her dedication in organising trainings and the race.

As a result of our advocacy to the ACT Legislative Assembly with the Auslan Rights Petition, an inquiry was held. We'd like to thank everyone who provided a submission to the Standing Committee about their experiences and to those who participated in the public hearing.

The report from the Committee was tabled in February this year and the Committee made 25 positive recommendations that show they listened to the community's requests. We (and our community) were very disappointed by the Government's response to the recommendations and will continue to monitor their progress and keep them accountable to the recommendations they accepted in principle.

We've continued supporting our Seniors with their monthly catch ups and it's great to see the friendships and connections growing.

With an exciting sneak peek into this financial year, we've also established a Men's Group led by Gavin Reid and a Youth Group lead by Rhiannon Gonlag under DeafACT. The responses have been fantastic, and we look forward to planning more events and sharing them with all of you.

As of October 2023, our DeafACT family has grown over 100 members! How amazing is that? Thank you to each one of you for contributing to the warmth and vibrancy of our community. Being the President has made me realise how much I love the community, supporting and advocating for everyone. I have enjoyed organising events so I can bring the community together and being able to see everyone happy, makes me very happy!
